GUIDELINES FOR FAMILY CAMPERS

Requirements for Reservations:

Total group capacity cannot exceed 10 unique guests at any time. If some guests leave, they still count towards a total count of 10.

For those staying in the VIPs capacity is limited to 2 people per room. For those staying in the Nurse's Cabin capacity is limited to 6 people total. For RVs, tent-camping and Retreat Cabins capacity is limited to 10 unique guests as mentioned above.

Any guests that have shown or been in close contact with anyone with COVID-19 symptoms (cough, shortness of breath, fever) in the last 14 days may not come to camp.

All guests must agree to abide by the guidelines in this document. Failure to do so may result in immediate termination of their reservation and loss of deposit. Any guests present with a contract holder are the responsibility of the contract holder.

Upon arrival:

At Mingus Mountain: upon arrival you should park in the main lot as you enter the gate on the left and then text both Annie Warner, Assistant Director and Cat Holbert, Executive Director at 928-634-5273 and 949-682-6552.

Safe Activity & Social Distancing:

Groups should consist of family groups and should be limited to 10 or fewer.

Because groups are assumed to be from the same family per the policy above we do not require guests within the same day use group to social distance or wear masks, but are reminded that good hygiene remains critically important (handwashing, cough covering, etc.)

Interaction with other groups at camp is strongly discouraged. In the event groups cross paths (within 6 feet) all participants within both groups must wear a face-covering that covers their mouth and nose. Groups should endeavor to avoid interaction with other groups as much as possible.

When any guest from a group is near another group, social distancing (6' or greater) must be observed. When this cannot be observed, a face covering that covers nose and mouth is required.

During mealtimes, only guests from the contract group may be together. Mixing groups at meals is prohibited.

Recreational Equipment Access:

Basic recreational equipment will be available at both sites. A cleaning and sanitizing area will be available in the vicinity of the recreational supplies. After use, participants will clean and sanitize the used equipment using the provided sanitizing spray and/or wipes.

Building Access at Mingus Mountain:

The only buildings available for tent camping family campers are the restrooms at the Ramada and the restrooms at LaPoint. Their showers may be taken at LaPoint.

All other family campers must only use the restrooms and showers located in their reserved building.

After using the bathroom and washing hands, family campers should use the available sanitizing wipes to wipe down the toilet flush handle, sink handles, and doorknobs. Used wipes should be disposed of in the trashcan/s located outside of designated restrooms.

Staff Availability:

Staff will be available for emergencies while guests are on site. At Mingus Mountain, Family Campers should use the numbers above to alert Annie and/or Cat.

Check-Out

Guests at Mingus Mountain should bring all garbage to the dumpster (located next to the maintenance shop) on your way out of camp or before.

Sign out at the same place you signed in or text upon departure.

Staff Will:

- Provide good role-modeling by wearing a face-covering when around others.
- Provide cleaning and sanitizing in the shared restrooms at 11am, 2pm, and after the final day users depart each day. In the event there are no day users staff will clean and sanitize at 5 pm.
- Staff will not enter family camper buildings unless alerted about a maintenance or housekeeping need while guests are on site.
- Maintain hand-sanitizing stations.
- Be available in case of an emergency.
